The site extends to 6.4ha. Although the final number of homes will emerge from a more detailed process at an average density of 20-30 homes per hectare, the likely capacity of the site can be assumed to be between 128-192.

The site would deliver a range of high quality market and affordable homes together with associated facilities. The development would also provide an appropriate contribution towards green infrastructure, children's play, sports and community facilities.

Site lies adjacent to Drayton Wood County Wildlife Site. The site's western boundary is well treed. Development on the site would respect and enhance the importance of the CWS.

There are no listed buildings on the site and the site does not lie in a Conservation Area.

The site relates well to the existing built up area of Hellesdon with an adjacent boundary to existing homes in Westwood Drive. The western and eastern extents of the site are bounded by substantial physical features of Reepham Road and Drayton Wood. A care home is located within Drayton Wood.

The development would need to ensure a high quality design which would respect the amenities of existing residents and the ecological value of Drayton Wood.

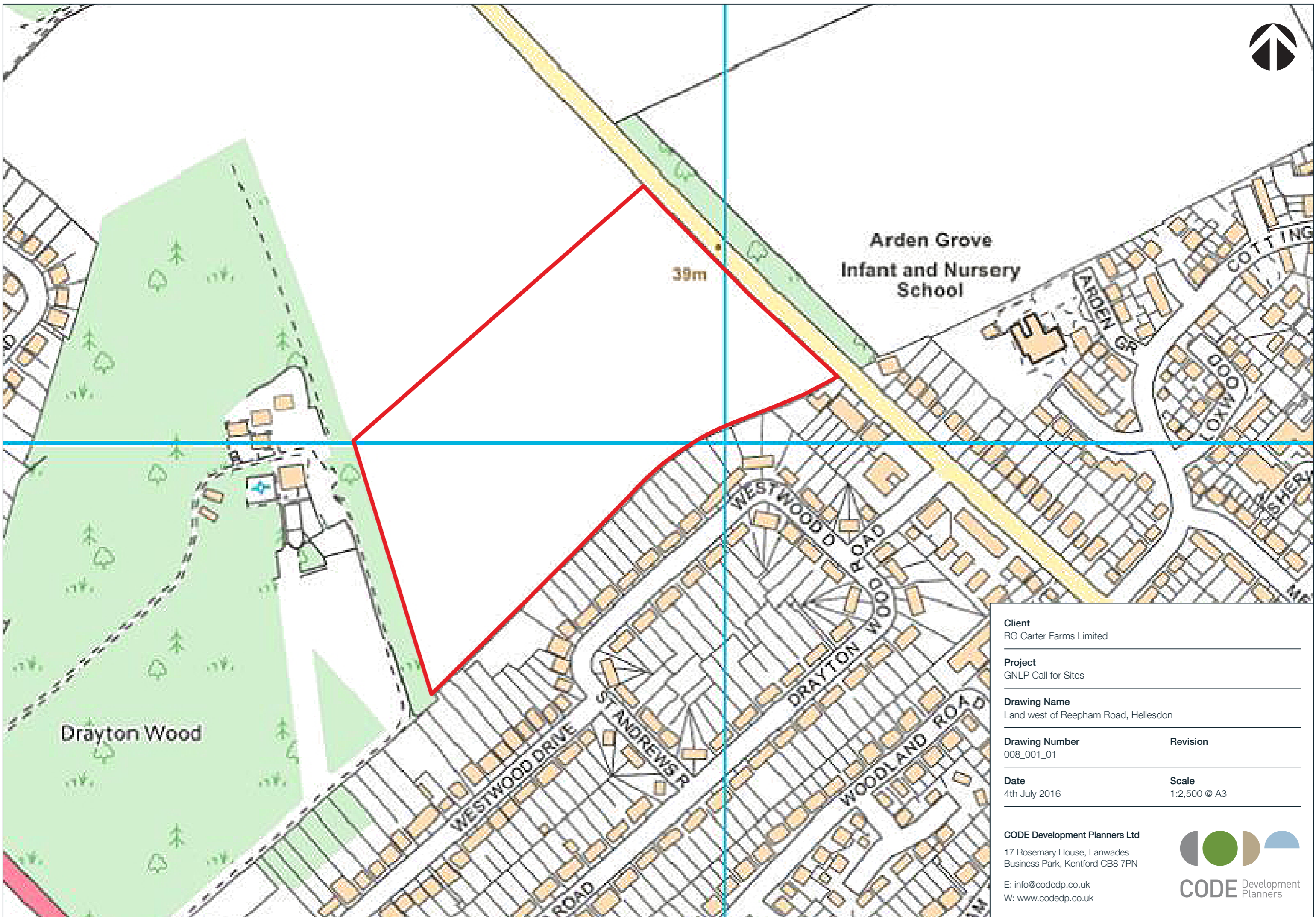
